Chapter 1 Application Procedure

1. Application Qualification

Applicant should be 18 years old and older in principle and have graduated from the last school within 5 years, who has completed at least 12 years of formal education in his/her native country or foreign countries or been recognized as having the correspondence academic capability. Must complete 150hours Japanese learning, JLPT exam etc qualified. There must be a financial supporter.

2. Date of Entrance April/July/October

3. Registration Period

From October 1st to October 30th for April Entrance (※An interview test has been scheduled from August,1)
 From January 5th to January 31st for July Entrance (※An interview test has been scheduled from December,1)
 From April 1st to April 30th for October Entrance (※An interview test has been scheduled from February, 1)

4. Application Procedures

Submit the required documents with screening fee of 20,000 yen within the period. (You can ask the deputy of this school.)

5. Screening Procedures

The screening will be done on the basis of paper test and interview before documentary elimination.

12. Notes

- ①Applicant who already has the passport should write “passport number” and “date of expiry” in Application Form.
- ②“Entry and departure history” in resume should be fully filled in correctly and the copy of the entry and departure history record in the passport should be attached.
- ③“Expected term of study” in Application Form should be from the entrance month of April/July/October to March two years after.
- ④Fill in correctly the dates of entrance and graduation in “academic history” of resume so that they should not be different from the dates in the submitted original certificate.
- ⑤Documents that are supposed to be written by the applicant and the payer should be written with their own hands.
- ⑥Official documents which are to be submitted should be issued within 3 months of the date of application and they should be attached with Japanese translation.
- ⑦If the applicant is the future graduate, the original of the graduation letter and the student registration certificate should be submitted. In this case, the original certification of graduated school should be submitted later upon the entrance of this school.
- ⑧Please keep a copy of all submissions for yourself to review.
- ⑨Enter 「—」 instead of leaving column blank.

13. Interview Screening

Interview screenings are to be conducted in the applicant's country etc. to confirm the Japanese proficiency, desire to learn and paying ability.

14. How to pay expenses

After notified that "authorization of resident eligibility" is issued, the applicant should transfer 1,019,000 yen in total by the name of applicant name, which includes screening fee , admission fee, one-year tuition fee, education materials fee , Learning activity expenses and facility maintenance and consumable fee, fee to enter and exit dormitory , half-year boarding fee and accident insurance, and Tuberculosis check up fee 10,000 yen within the designated periods to the designated bank account.

Chapter 2 Characteristics of This School

1. Scholarship

Scholarship systems are available for the prospective applicant. (Screening is required.)

- Scholarship sponsored by Asuka Japanese Language School.
- Scholarship sponsored by Japan Student Services Organization

2. Counseling

In our school, we conduct counseling to all students on a regular basis. We also have a staff member who is in charge of counseling. Any students who wish to receive counseling can do so any time. We will stay close to each student, and give full mental support to helping them with their problems, such as difficulty in adapting to life in Japan and relationship with friends.

~We have passionate professionals who will help you until graduation. ~

3. Feature of Curriculum

①We have a “Japanese” only environment so you can acquire practical Japanese skills.

You cannot acquire such skills in an environment where there is a bias in nationality.

At our school, there are many students with different background. (China, Korea, Nepal, Indonesia, Vietnam, Sri Lanka, Russia, The United States of America)

Being in an environment where common language is “Japanese only”, you can acquire practical Japanese skills.

②Focusing on building communication skills

In our school, we conduct Japanese communication education especially focusing on improvement in communication skills.

Rather than a “free talk”, we conduct a communication lesson that is based on our communication educational theory (communication education based on Oral Proficiency Interview).

③Balanced Curriculum

We conduct the following two lessons in balance.

- Lesson focused on examinations: Lesson for Japanese Language Proficiency Test and Examination for Japanese University Admission.
- Comprehensive Japanese: We focus on presentation to acquire practical Japanese to enable you to enroll in Japanese university and for employment in Japan.

4. Graduate Certificate

Graduate Certificate are offered to the students who have completed the required length of study (two years for April entrance students, 1 year and 9 months for July students and 1.5 years for October entrance students) and have attended the class with 90 % and larger attendance rate and have passed the graduation test.

5. Dormitory for foreign students.

School dormitory is equipped for the foreign students. The dormitory features all daily living necessities, such as not only bathes, restrooms and kitchens but also TV set, refrigerators, washing machines, beds and bedclothes, or tableware (students are supposed to cook by themselves). Students are supposed to take with them a set of tableware (including dish, cup or bowl) and a set of bedclothes when they leave the dormitory. It takes about 15 minutes by bicycle from the dormitory to the school.

Asuka Japanese Language School Dormitory Regulations for Foreign Students

1. General Rules

Article 1

1. Asuka Japanese Language School is the boarding school. Every student must enter the dormitory.
2. Borders must conform to the regulations.
3. Borders who cannot follow the rules in spite of repeated warnings, they may be forced to return home.
4. Borders must leave the dormitory soon after they become no longer the student of this school because of graduation, dismissing or expulsion.

2. Rules for dormitory admission

Article 2

1. The contractor shall be the person who enters the dormitory.
2. The guardian of the border living in the home country or the intermediary shall bear the final responsibility to pay the boarding and other fees.

Article 3

1. The period of the contract of lease between the school and the boarder shall be as specified in the boarding contract.
2. The term of the contract is the period of attendance at school of the border. The border shall not be allowed to leave during the term of the contract. Students who enter our school in April and October may move out of their dormitories after six months. Students who enter our school in July may move out of their dormitories after nine months. All students must get permission from the school before moving out of their dormitories.
3. The boarding fee must be paid for 3 months at a time during the designated period by the school.
Fee to enter and exit dormitory: 100,000/student (Please pay altogether when entering the dormitory)
Boarding Fee: 23,000 / months for a student (Additional utility fee is needed)
4. Gas and electricity bills shall be borne by the boarder. The boarder must pay the bills provided by the school within the designated periods by themselves.
5. After the termination of agreement, leaving dormitory shall conform to the "Leaving Dormitory Rules."

Article 4 Three borders should live communally in one room in principle. Students may be placed with Roommates from different countries.

Article 5 The entrance procedure to the dorm shall be taken on the basis that the border understands and agree with the dormitory rules.

Article 6 Contract of lease of the room shall be effected between the school and the boarding applicant after signing the contract to enter the dormitory.

Article 7 The contract shall be canceled automatically when the dormitory becomes uninhabitable due to accidental force, such as convulsion of nature or fire.

Article 8 The school may expel students who have trouble living and studying in Japan (violating school rules, causing trouble with roommates and neighbors, etc.)

3. Rules within the dormitory

Article 9

The boarder shall keep the regulations provided based on the dormitory rules and regulations, understand the cohabitation and live so as not to cause residents living near the dormitory and other boarders.

Article 10

Possesses and money shall be managed with self-responsibility. As the loss within the dormitory could not be compensated, every boarder should be careful by oneself.

Article 11

As people other than the contractor and the designated user of the room shall not be allowed to stay at night in the dormitory,

Article 12

1. The boarders should refrain from visiting other boarders' rooms to prevent invasions of privacy.
2. Visiting the rooms among males and females after nine at night shall be prohibited.

Article 13

The boarder who would return home or be absent for a long period to visit his/her family shall take the procedures as prescribed beforehand at school.

Article 14

1. The Boarder shall always smarten up and keep clean within and outside of the room and be careful not to cause residents living near the dormitory or other boarders trouble due to the noise or bad smell.

Manager of each room is the person responsible for each room.

2. Garbage must be separated based on the Waste Management Law. Burnable and non-burnable garbage needs to be put separately into each designated paid plastic bag. The other garbage needs to be put into clear or translucent plastic bags. Garbage must be placed in the designated dumpster by 8:30 in the morning on the designated days to be collected.

3. Bicycles must be placed in the bicycle parking lot and be careful not to cause the residence living near the dorm trouble.

Article 15

School staff might step into the room to manage the facility and fixtures with prior announcement. However, they could step into the room without prior announcement at the time of the crisis when the school perceives a need to do it.

Article 16

The boarder shall conserve the facility, equipments or fixtures the school is lending. He/she shall contact the school immediately in case of breakage or failure. However, in case of intent or negligence, it should be compensated at actual cost.

Article 17

The boarder shall use only the key given by the school at the time of entry, and in case of missing, missing notification must be submitted to the school. Making a spare key without permission shall not be allowed.

4. Leaving rules of the dormitory

Article 18

The boarder shall not be allowed to leave the dormitory without permission during the contract period.

Article 19

1. The date of graduation shall be the date of expiry of the term of contract.
2. The boarder who has graduated from school must leave the dormitory by March 15th.
(If March 15th is a Saturday, Sunday or public holiday, it will be the day before that.)

Article 20

In case of dismissing or expelling from school, the boarder shall leave immediately after the procedure.

Article 21

When leaving the dormitory, the room and fixture must be cleaned. Leaving check shall be conducted before leaving. All the roommates shall stand by at the time of leaving check. When there are damages or deficiency, the boarders who had been living in the room shall bear the compensations or repair costs.

Examples: 2,500 yen for the repair of one fusuma
5,000 yen for the repair of one tatami
10,000yen for the repair of one vacuum cleaner

5. Manners and Prohibited Items

AS the dormitory of this school for foreign students is the private apartment and not the ordinary one exclusively for the students, there are a lot Japanese residences living near it. In such a living environment, the foreign students can learn Japanese lifestyle or common knowledge of Japanese. To respect each other's personal quality and to understand and cooperate with each other not to cause trouble are necessary and important to have a comfortable life in Japan.

Article 22

Manners

1. Greeting is the basic of cohabitation and social life. Make the usual greetings to the other boarders and the residence living near the dorm both in and out of the dormitory. If neighbors give advice to you, listen deeply to them. (You can't say "I don't understand Japanese.")
2. Always look after his/her own health and keep clean the room.
3. Always keep clean the kitchen, restroom and bathroom. The boarder must clean the dirtiness by his/her-self after using so that the others can use comfortably.

Article 23

Prohibited matter

1. Infractions of Japanese laws and regulations

- Purchasing, bringing in and using of Hazardous materials and Explosives materials
- Purchasing · bringing in and using Drugs
- Morals of gambling, Violence, etc. Disturbing order

2. To walk into the room with shoes on except for the entrance and to enter the tatami room with slipper on
3. Smoking outside the designated areas.
4. To take the trash out on the day other than the designated days to collect garbage and to keep the garbage in the balcony.
5. To cause the nuisance to the residences living near the dorm, such as noises in and outside of the rooms.

Examples: Making loud noise late at night → Don't speak, sing songs, or listen to music loudly in your room after 9pm.

Don't make loud noises or speak loudly when coming back home from a part time job late at night, especially after midnight.

Making loud noises in the balcony and hallway → Don't speak loudly in the balcony and hallway.

Closing doors loudly → Close the door slowly and quietly to prevent loud noises.

Running around in your room → Don't make heavy footsteps.

Bothering residents living below your room by making loud noises to cut some food on the floor → Cut food on the table, not on the floor.

6. To stay without permission in other rooms outside the dormitory or to let others than the contractor stay. Also, move to another room in the dormitory and leave the dormitory without permission.
7. To keep animals in the room or near the dormitory.
8. To drain the leftovers and oil into the drainage.
9. To park the bicycle at the place rather than the designated place.

Article 24 Other

School may give the following penalties to students who significantly violate dormitory regulations.

Chapter 3 References

1. Notes before visiting Japan

- ① 「After the original “authorization of resident eligibility” are issued, submit the validated passport and the original of entrance certificate to Japanese Embassy or Japanese Consulate to apply for visa.
- ② As the “authorization of resident eligibility” is effective for 3 months, come to Japan within the period.
- ③ “Authorization of resident eligibility” , passport and visa are very important. Keep them at hand.
- ④ Enter Japan within the designated periods of time by the school. As the school staff will pick you up, make sure to notify the flight number, the name of arriving airport and the time of arrival if you decide the date. You are required to pay the transportation fee (3,000 yen for one student). If you cannot enter Japan within the designated periods, notify the school beforehand. In that case the transportation fee can be higher.
- ⑤ Treatment of chronic disease (Come to Japan after finishing treatment completely. Prepare for the medicine.)
- ⑥ Practice to ride a bicycle (In Oita, students use bicycles for transportation. If you cannot ride, practice it before coming to Japan.)

2. Notes when coming to Japan

- ① Original of “**Authorization of resident eligibility**” ,original of “**entrance certificate**”,passport and filled-in E/D registration card for foreigners are required at the time of disembarkation procedures.
- ② 1 Personal seals
- ③ Several photos (3cm x 4cm)
- ④ Tools to study (bag, dictionaries, stationery etc.)
- ⑤ Clothes (everyday clothes, shoes, winter sweater, winter clothes, etc. Full dress for ceremonies, such as entrance and graduation ceremonies, Suits)
- ⑥ Umbrella and rain gear for bicycle
- ⑦ Instant foods are useful under unaccustomed surroundings during initial phases of the entrance.
- ⑧ Bring the expenses for “National Health Insurance,” “transportation” and “half –year living expenses” (including 20,000 or so to buy a bicycle) with you.

3. Notes after coming to Japan

You have to get used to the Japanese customs and keep the law so that you can enjoy the study and the life in Japan pleasantly and in good health as a foreign student.

- ① The traffic regulations in Japan are very strict. You have to obey the traffic regulations when you walk, ride a bicycle and drive a car. Neglect of traffic regulations can not only endanger your life but also do a lot of damage to others.
- ② Japanese people are known to be very diligent in the world. Get serious to do anything and respect punctuality.
- ③ Acquire the customs which ordinary Japanese have in their lifestyle.
Examples
 - To be careful for sanitation and keep yourself neat and tidy.
 - Do not speak loudly.
 - Keep the manner and do not forget greetings and courtesy.
- ④ We have 「Waste Management Law」 in Japan. Keep in mind that garbage must be separated properly.

4. Comprehensive Accident Insurance (compulsory participation)

Students of this school must enter the comprehensive accident insurance to study and live in Japan at ease.

- ① Comprehensive Accident Insurance: Personal insurance
- ② Insurance fee : 11,000 yen
- ③ Insurance term : 2 years
- ④ Means for payment: Lump-sum payment

5. Tuition fee for Asuka International Bridal and Hotel Tourism College

(In case of entering the Asuka International Hotel and Wedding Department after graduation from the Japanese Language of this school with attendance rate of 90% and should attend the open campus 1 time)
